Jurisdictions requiring age 19 or older, for tobacco sale OR purchase

I. Jurisdictions banning the "SALE" of tobacco or cigarettes to persons under age 19 or 21:

U.S. States; International:

- **Alaska** – bans sale to person under age 19, 2007; included nicotine products in 2012
- **NJ** – **bans sale, furnish or give to under age 19, approved January 2006**; included electronic smoking devices in 2011
- **Utah** – bans sale to under age 19, 2010
- **Island of Hawaii (County only)** – bans sale to under 21 (grandfathers in ages 19-20), voted through on 1/22/13, effective July 1, 2014.
- **Dubai** – bans sale to under age 21, includes electronic smoking devices, effective early 2014.

New York City and Counties:

- **New York City** – **bans sale to under age 21, signed 11/19/13**; includes electronic smoking devices.
- **Onondaga County** – bans sale to under age 19, 2009
- **Suffolk County** – bans sale to under age 19, 2005; includes electronic smoking devices.
- **Nassau County** – bans sale to under age 19, 2006

Massachusetts' municipalities:

- **Needham** – **bans sale to under age 21, 2005**
- **Sharon** – **bans sale to under age 21, 2013**
- **Dover** – **bans sale to under age 21, May 2013**
- **Ashland** – **bans sale of to under age 21, effective 1-1-14**, tobacco and nicotine delivery products (comprehensive policy addresses other access points)
- **Canton** – **bans sale to under age 21, effective 2014**, repealed in 5 years if ineffective
- **Arlington** – **bans sale to under age 21**, 3-year phase in, starting with age 19, May 2013
- **Belmont** – bans sale to under age 19, 2012
- **Brookline** – bans sale to under age 19, 2012
- **Walpole** – bans sale to under age 19, March 2012
- **Watertown** – bans sale to under age 19
- **Westwood** – bans sale to under age 19, February 2012

Ontario, Canada – bans sale or supply to persons under age 19, 1994

II. Jurisdictions contemplating a ban on tobacco sales to persons under age 21:

- Washington, DC – introduced on 11/5/13.
- Suffolk County, NY – noted in 11/21/13 CBS news story.
- Massachusetts: Foxborough, Franklin (to discuss in autumn 2013), Mansfield, Medway, Millis, Newton, Weston, Wellesley, Dedham, and Norwood.
